Baysville Market Information

1. The stalls are approximately 10 feet wide by 10 feet deep.
2. Individual prices of items must be posted for all items.
3. Season stall fees should be paid in advance.
4. Location of the stall will be determined by the market manager.
5. Market manager must be notified the day prior to market day if not attending. This is a courtesy to the market and manager.
6. Vendors are responsible for their own stalls and any equipment needed to sell their product. They are also responsible for the clean-up of their stalls at the end of each market day. Any vendor needing an electrical hookup must contact the market manager prior to the market.
7. The following goods are considered to be eligible for selling at the market subject to any federal, provincial or local regulations which may apply: vegetables, honey, maple syrup, fruit and berries, meat, fish, poultry, home baking and preserves, firewood, flowers, plants and shrubs, crafts, eggs (must be graded)
8. The market management will be responsible for the placement of advertisement in local publications, website, etc., and signage on the day of the market.
9. Each food vendor must complete the Simcoe Muskoka District Health Unit Vendor Application and submit it to the SMDHU. https://www.simcoemuskokahealth.org/docs/default-source/jfy-businesses/PSS_Temporary_event_Vendor_application.pdf?sfvrsn=0
